

## **Public Notice - Superintendent Contract Hearing**

Pursuant to N.J.S.A. 18A:11-11, the Upper Pittsgrove Board of Education (hereinafter the "Board") is providing notice of its intent to hold a public hearing and to take action to amend, extend, renegotiate and/or alter contract terms and conditions of the district Superintendent at its regular meeting to be held at the Upper Pittsgrove School, located at 235 Pine Tavern Road, Monroeville, NJ on September 18, 2019 at 6:30 PM.

Section 5 of the Act amended N.J.S.A. 18A: 11-11 requires boards of education to provide public notice 30 days prior to the renegotiation, extension, amendment, or alteration of an employment contract with the superintendent of schools, assistant superintendent of schools, or school business administrator; and WHEREAS, said public notice was provided to the public via posting outside the office of the Board Secretary located at 235 Pine Tavern Road, Monroeville, NJ 08343 and on the district's public website on August 27, 2019.

Section 5 of the Act amended N.J.S.A. 18A: 11-11 to require boards of education to provide public notice of a public hearing 10 days prior to the renegotiation, extension, amendment, or alteration of an employment contract with the superintendent of schools, assistant superintendent of schools, or school business administrator; and WHEREAS, said public notice of a public hearing is provided to the public via posting outside the office of the Board Secretary located at 235 Pine Tavern Road, Monroeville, NJ 08343, on the district's public website, and legal advertisement in the South Jersey Times on August 29, 2019;

The Upper Pittsgrove Board of Education hereby designates starting at 6:30 P.M. in the Upper Pittsgrove School, 235 Pine Tavern Road, Monroeville, New Jersey, 08343, September 18, 2019 as the public hearing required by the Act, after which the Board may take action to amend the Superintendent's contract.

Prior to this action, the Board will permit the public to make comment on the proposed contract addendum at the aforementioned meeting. The Board, pursuant to Open Public Meetings Act, specifically N.J.S.A. 10:4-12 (b), shall not publicly discuss personnel matters. However, the Board will give all comments appropriate consideration. Copies of this contract addendum are available for review by contacting Lisa DiNovi, Board Secretary.

The Board, pursuant to N.J.S.A. 10:4-12 (b), the Open Public Meeting Act, shall not publicly discuss personnel matters and shall not respond to comments made by members of the public.

Please be aware that the subject of this hearing retains the right of privacy and shall retain all rights regarding defamation and slander according to the laws of New Jersey. The Board shall not be held liable for comments made by members of the public.
